 - 2. a motion for call for vote on an issue/proposal
- This is particularly relevant to procedures for email discussion
- RROO applies to in-person meetings
 - applicability email discussions?
 - see comments from DASC Chair



14. Entity-Based Projects in DASC

- Proposed P1800 SystemVerilog project has raised the issue
- IEEE-SA has formed a Corporate Advisory Group (CAG)
 - represents interests of IEEE-SA Corporate members
 - can sponsor entity-based projects
 - if no society-based sponsor is interested
- IEEE-SA Corporate Office provides support services
- DASC can sponsor entity-based projects
- Issues
 - entity membership of DASC (fees and rights)
 - choice of membership for DASC projects
 - relationship between DASC and CAG
 - P1800: interest to sponsor, coordination with P1364
